Kewaunee County Board of Supervisors Race is Set for Spring Election

KEWAUNEE, WI – The ballot for the April 3, 2018 spring election in the race for the Kewaunee County Board of Supervisors has been narrowed down to 28 candidates following Tuesday's primary that brought nearly 350 people to the polls in two districts.

The majority of residents who voted in the Town of Lincoln chose Cory Cochart and Mark Kusniesz to move forward in the race for District 2, eliminating Joseph Musial. And, in the Town of Franklin, the greater number of residents who cast a ballot picked Thomas Cretney and John Wochos in District 10, defeating Duane Ducat.

Primary Race Results

District 2 – Town of Lincoln

Cory Cochart – 116 Votes

Mark Kusniesz – 71 Votes

Joseph Musial – 17 Votes

District 10 – Town of Franklin

Thomas Cretney – 60 Votes

Duane Ducat – 33 Votes

John Wochos – 44 Votes

The Kewaunee County Board of Supervisors is made up of 20 seats; 15 incumbents are running for re-election and five of those races will be contested in six weeks, while 10 incumbents run unopposed.

In the remaining five races, the seat for District 5 that represents the Village of Luxemburg – Wards 4 & 5 is vacant, which means a write-in candidate could win.

District maps can be found on the Kewaunee County website, www.kewauneeco.org under the blue "District Maps" tab on the left side of the home page, which is also where unofficial election results can be found for both the primary and spring election.

There were more than 1,900 Kewaunee County residents who cast a ballot in the primary. And, on Tuesday, April 3, 2018, the polls will be open from 7:00 a.m. – 8:00 p.m.
