## **Kewaunee County Board of Canvassers Completes Verification of Votes**

KEWAUNEE, WI – The Kewaunee County Board of Canvassers has verified ballots cast by 5,483 registered voters from the Tuesday, April 3, 2018 spring election and finalized the Kewaunee County Board of Supervisors.

The process was done in three hours on Tuesday, April 10, 2018 at the Kewaunee County Administration Center, 810 Lincoln Street, Kewaunee.

In the race for the Kewaunee County Board of Supervisors, the seat for District 10 in the Town of Franklin will go to candidate Thomas Cretney, who won a drawdown stemming from a 102-vote tie with opponent John Wochos. The Board of Canvassers had chosen to draw a name out of a box to decide the winner of that seat.

The Kewaunee County Board of Supervisors will meet on Tuesday, April 24, 2018 at 5:30PM for an organizational session and elect the Kewaunee County Board of Supervisors Chair, as well as find out which committee(s) that they will serve.
